The resolution are: -

1 PRESCRIBED INFORMATION

2 PREAMBLE

Following the AKBC Special General Meeting of 17th October 2023 at which Members voted in favour the sale of the property at 273 Remuera and continuing the process of merging of AKBC and RBC, further resolutions by Members are requested.

An Amalgamation Proposal, including a proposed Constitution, for the amalgamation of RBC and AKBC has been sent to all members of both societies and available on the website www.akbc.co.nz since late August 2025. A Special General Meeting of RBC members (22nd)

November) and an Annual General Meeting of AKBC (23rd November) have been called to approve the resolutions set out below.

The purposes of the resolutions are to:

- (i) approve the Amalgamation Proposal (including the proposed Constitution) under s 194 (2) of the Incorporated Societies Act 2022; and
- (ii) set out the conditions which must be satisfied before the amalgamation can proceed and take effect.

3 RESOLUTIONS

- 3.1 **Approval of Amalgamation Proposal.** The Amalgamation Proposal for the amalgamation of RBC and AKBC is approved, and the proposed Constitution is adopted.
- 3.2 **When the amalgamation is to take effect.** The amalgamation will take effect when and if the sale of AKBC's property at 273 Remuera Road settles on the terms set out in the existing agreement for sale and purchase ("ASP").
- 3.3 Registration of amalgamation.
 - a) If the ASP settles on the terms therein on or before 19 December 2025 the amalgamation shall be registered under s.197 of the Act as soon as possible.
 - b) If the ASP does not settle on or before 19 December 2025, unless the Executive of RBC and the Board of AKBC agree to an extension of time for settlement, Resolution 3.1 above shall lapse and be of no effect, and the registration of the amalgamation shall not proceed.
- 3.4 **Correction of errors and omissions.** The Steering Committee (comprising representatives of both societies) may make amendments to the proposed Constitution which have no more than minor effect, correct errors, are technical alterations or if requested by the Incorporated Societies Registrar for compliance with the Incorporated Societies Act 2022.
